2019 Internship/Scholarship Awards

The Fremont Soil and Water Conservation District is sponsoring up to five internships/scholarships in 2019.

PURPOSE – To award up to five \$1000 internships/scholarships to high school seniors who reside in Fremont County.

AMOUNT – Up to five internships/scholarships will be awarded in the amount of \$1000 each.

- A minimum of eight hours internship is required by the recipient and must be completed by September 1, of the current year. If not completed by September 1st of the current year, the scholarship is null and void.
- The money will be paid in two equal installments of \$500 each.
- Recipients must bring their fall grade report and spring class schedule to the Fremont SWCD office in January, 2020, to receive the first \$500 check.
- The same procedure is to be followed in January, 2021; recipients must bring their fall grade report and spring class schedule to the Fremont SWCD office in January, 2021, to receive the final installment of \$500.
- The eight hour internship is required by September 1st of the current year.
- Checks will be null and void if not cashed within 90 days.

BASIS OF AWARD – Criteria consideration will be leadership, and scholastic achievement. Pursuing an education in any field of science, agriculture or natural resources is preferred but not required. Leadership includes service, character, and self-motivation.

SELECTION – **ALL applications must be typed or completed with a word processor.** Hand written applications will not be accepted. APPLICATION DEADLINES

High school seniors residing in Fremont County must have their applications to the Fremont Soil and Water Conservation District office no later than February 25, 2019. Applications received after February 25, 2019 will not be considered.
